## **WINTER 2021-2022 OLNEY CRAFTS MARKET GUIDELINES & APPLICATION** Sunday, NOVEMBER 14, 2021 through Sunday, MAY 1, 2022

**Guidelines For Entry:** Crafters must be juried to participate in the Olney Artist Market and should have a working email address.

**Contact** Janet Terry or Bobbi Espinoza (see below) to make arrangements for jurying. You need only submit your work for jurying in your first year with us, unless you start a significantly different style or medium.

**Market Operation:** The Olney Crafts Winter Market starts on Sunday, NOVEMBER 14, 2021. We plan to operate through Sunday, May 1, 2022. Hours of operation are 9:00 a.m. until 1:00 p.m. Once accepted by the Market, crafters may participate for the remainder of the winter season and need not reapply until the next season. Applications may be received via email, mail or in person.

**Please Note:** Crafters should apply for the winter season by November 1, 2021. We encourage earlier return if possible. Vendors who sign up and PAY for the entire Winter Market in advance get 2 Sundays free.

**Location:** 2801 Olney-Sandy Spring Rd, at the corner of Prince Philip Dr & Rt 108, Olney, MD.

**Cost:** \$25.00 per space. Vendors may pay by check, money order, Square or cashier's check, made payable to "Olney Crafts Market". Deposit of \$25 required for first-time Vendors.

**Signage:** Each vendor will display a neat, legible sign identifying the business. No tents are necessary for the Winter Market. Vendors may sell out of their vehicles.

**Storage:** The Market will allow vendors to store items in our trailer IF THERE IS ROOM. However, the Market will NOT be responsible for any losses or damage. Please check with on site Market manager before leaving anything behind.

**Applications:** The winter market application is solely for the winter. Vendors must reapply for the spring/summer season.

**Please Note:** Hospital will NOT clear snow or ice from market area. In the event of hazardous conditions, the market will close.

### **Terms and Conditions:**

1. Crafters shall conduct themselves in a professional manner.
2. Crafters are expected to be completely set up before the Market opens and agree to sell during the entire duration of the market day, unless the Market closes due to bad weather.

3. Crafters are only allowed to sell items formally approved by the Market Manager or review committee.
4. Crafters must comply w/ all federal, state and local regulations.
5. Crafters will confine all material to assigned space.
6. Crafters will not approach a customer viewing another artist's display.
7. Crafters will not use profanity or become physically abusive.
8. Crafters will be responsible for the behavior of family and friends.
9. Crafters may not 'hawk' their wares (in an aggressive manner).
10. Vendors must provide garbage receptacles for any waste generated by their wares and remove their own garbage from the market. Receptacles provided by the Market are intended for the use of our customers and guests.
11. There is no smoking or vaping at the market.
12. Crafters whose products (scents and sounds) may have an impact beyond the confines of booth must be sensitive to impact on others and remove those products if asked to do so.
13. No pets are allowed.

**Termination:** The Market reserves the right to terminate the agreement at any time. All terms and conditions shall survive termination.

**PANDEMIC PRODEDURES:** IF NOT VACCINATED, VENDORS AND CUSTOMERS ARE URGED TO WEAR A MASK. SOCIAL DISTANCING IS REQUIRED.
