FOOD VENDOR GUIDELINES AND APPLICATION, WINTER 2021-2022

DATES: Sunday, NOVEMBER 14, 2021 through Sunday, MAY 1, 2022

Market Operation: The Olney Farmers and Artists Winter Market opens Sunday, NOV 14. We plan to operate through Sunday, MAY 1, 2022

Hours of operation are 9:00 a.m. until 1:00 p.m. Once accepted by the Market, vendors may participate for the remainder of the winter season and need not reapply until the next season. Applications may be received via email, mail or in person.

Please Note: Vendors should apply for the winter season by November 1. We encourage earlier return if possible. Vendors who sign up and PAY for the entire Winter Market in advance get 2 Sundays free.

Location: 2801 Olney-Sandy Spring Rd, at the corner of Prince Philip Dr & Rt 108, Olney, MD.

Cost: \$25.00 per space. Vendors may pay by check, money order, Square or cashier's check, payable to "Olney Farmers & Artists Market".

NEW APPLICANTS: Please send \$25 deposit by November 1st.

Canopy: Tents are required for all food vendors. Each vendor will display a neat, legible sign identifying the business.

Storage: The Market will allow vendors to store items in our trailer, IF THERE IS ROOM. However, the Market will NOT be responsible for any losses or damage. Please check with on site Market manager before leaving anything behind.

Applications: The Winter Market application is solely for the winter. Vendors must reapply for the spring/summer season.

Please Note: Hospital will NOT clear snow or ice from market area. In the event of hazardous conditions, market will close.

Terms and Conditions:

1. Vendors must be licensed by Montgomery Co. Health Dept (there are some exceptions for baked goods only)
2. Vendors must conduct themselves in a professional manner.
3. Vendors are expected to be completely set up before the Market opens and agree to sell during the entire duration of the market day, unless Market closes due to bad weather.
4. Vendors must comply with all federal, state and local regulations.
5. Vendors will confine food to assigned space.
6. Vendors are responsible for conduct of family and friends

7. No pets are allowed.
8. Vendors may not 'hawk' their wares.
9. Vendors must provide garbage receptacles for any waste generated by their wares, and remove their own garbage from the market. Receptacles provided by the Market are intended for the use of our customers and guests.
10. There is no smoking or vaping at the Market.
11. Vendors must comply with all Montgomery County Health Laws. The Market can provide contact information and guidance, if needed.
12. **Please check with Market management in advance, before adding any new foods to your menu that were not on your application.** No unapproved items are allowed without permission.
13. Food vendors are admitted based on the type of menu items being offered and products needed. Fresh, local and nutritional are preferred. This category is the most competitive of the application process.

Termination: The Market reserves the right to terminate for any reason. All terms and conditions shall survive termination
